Repair and Repave approximately 800 LF x 22 Ft. of Trace Creek Rd.

Bids for the repair project will be received at White Bluff Town Hall, located at 52 Graham St., P. O. Box 300, White Bluff, TN 37187 until 3:00pm (local time), Wednesday, September 25, 2024. At that time, the bids received will be publicly opened and read. THE TOWN OF WHITE BLUFF RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS, WAIVE INFORMALITIES, AND ACCEPT THE BID DEEMED TO BE IN ITS BEST INTEREST.

**BID SPECIFICATIONS – TOWN OF WHITE BLUFF, TN
ROADWAY REPAIRS FOR TAYLOR TOWN RD. AND TRACE CREEK RD.**

The Town of White Bluff, TN is requesting bids for the following roadway repairs:

Repair and Repave approximately 400 LF x 20 Ft. of Taylor Town Rd.

Repair and Repave approximately 800 LF x 22 Ft. of Trace Creek Rd.

The projects include the following work: Furnishing and paying for all necessary labor, materials, equipment, tools, overhead, profit, permits, fees, testing, utility location verification, traffic control, pavement markings, base stone and asphalt paving courses.

Damaged surfaces to be cold planed, leveled and repaved; blending the repaired, finished surface into the existing surfaces on either side of the repair area. Repair areas should have a slight center crown to allow for effective water runoff. Taylor Town Rd. to receive centerline and edge striping; Trace Creek to receive stop bar at Hwy 70 intersection but no striping.

Although there is flexibility in the repair schedule, the repair jobs are to be completed by the end of the 2024 paving season.

Bidders are strongly encouraged to visit the project sites in person before submitting a bid. An approximate map of each location is provided in this packet.

Any bid received after the scheduled closing time for receipt of bids will be returned to the bidder unopened. Bids will be required to remain open for acceptance or rejection for sixty (60) calendar days after the date of the opening bids.

All bidders must be prequalified with the Tennessee Department of Transportation (TDOT). Roadway repairs will be constructed in accordance with the Town of White Bluff's Subdivision Regulations and the current TDOT Standard Specifications for Road and Bridge Construction.

All bidders must be licensed Contractors as required by the Contractor's Licensing Act of 1976. ITCA Title 62, Chapter 6. No bid will be opened unless the sealed envelope containing the bid provides the contractor's license number, date of license expiration, and that part of the contractor's classification applying to the bid. In the case of joint ventures, this information must be provided by all parties submitting the bid.

No award of any contract will be made to any firm or individual that is currently debarred by the State of Tennessee or the Federal Highway Administration.

As a governmental entity, The Town of White Bluff must require all bidders to submit an affidavit with their bid attesting that the bidder operates a drug-free workplace program that complies with T.C.A. §§ 50-9-101 *et seq.* A bidder drug-free workplace affidavit is attached to the bid form and must be completed and submitted with bid.

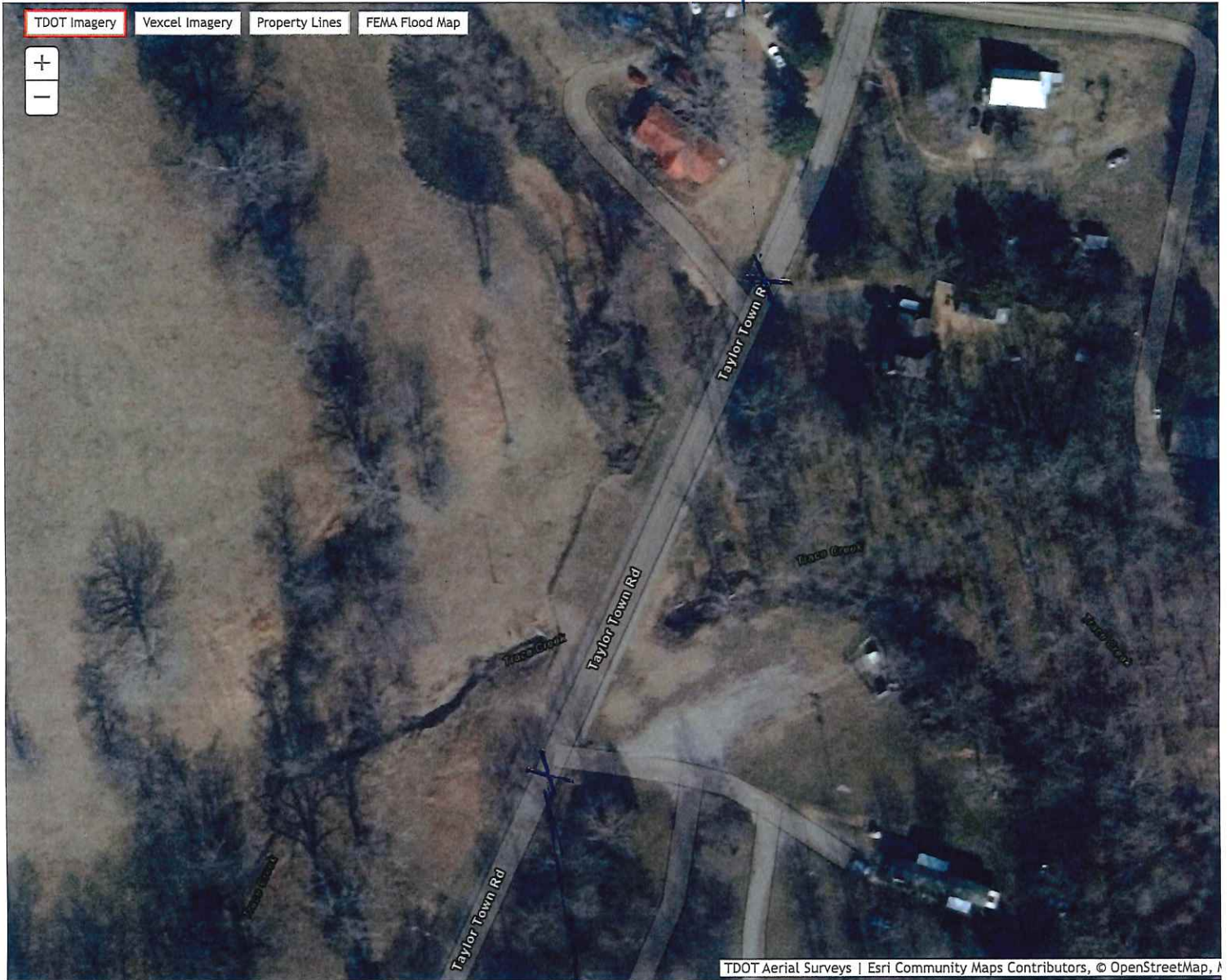

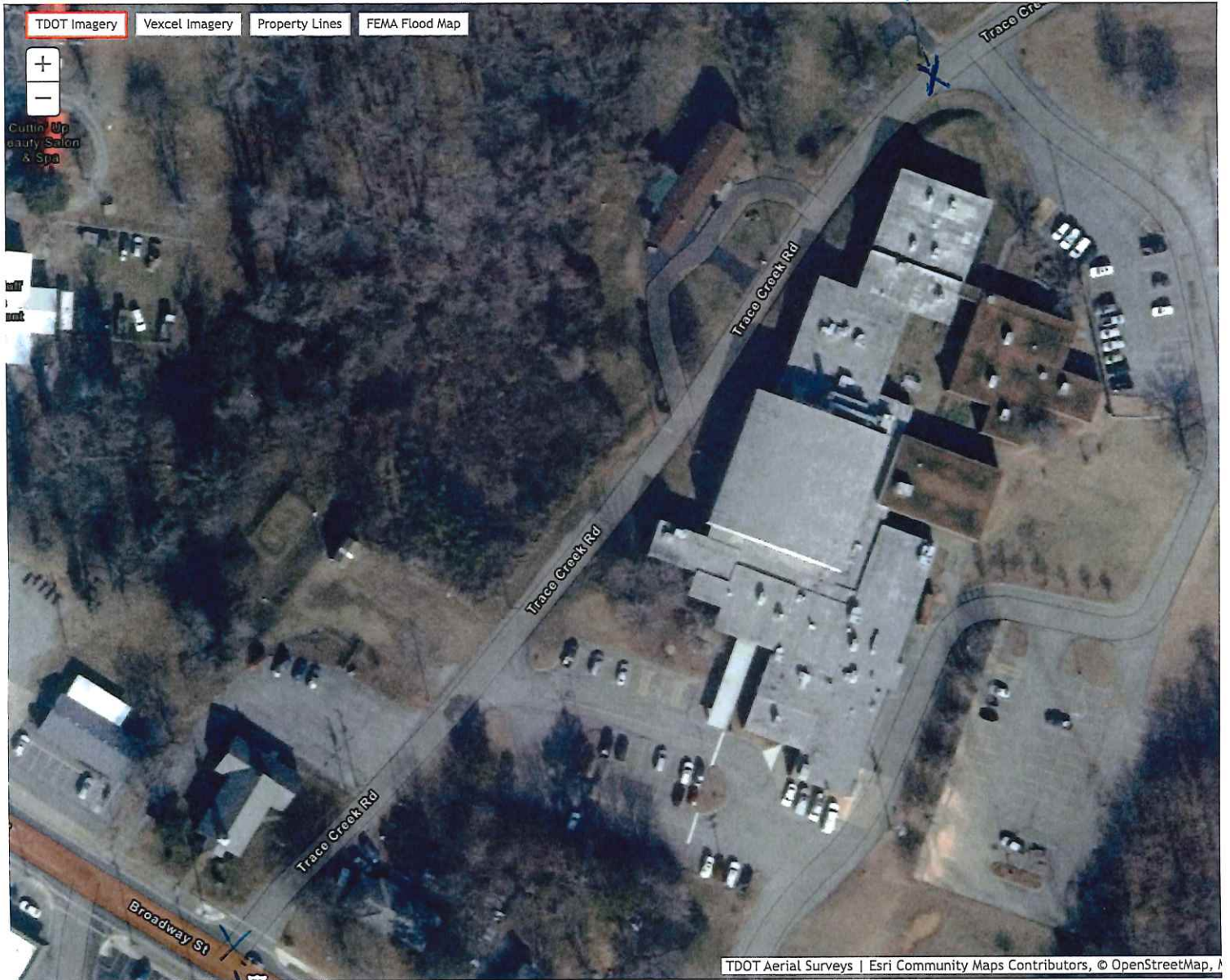

PROJECT LOCATION NARRATIVE – TAYLOR TOWN RD.

Repair and Repave approximately 400 LF x 20 Ft. of Taylor Town Rd.

The repair site begins approximately .6 miles from the intersection of Hwy 70 and Taylor Town Rd. and runs approximately 400 LF northeastward on Taylor Town Rd. Repair area is indicated with “BEGIN” and “END” painted on the roadway surface. An approximate map of the area is shown above.



PROJECT LOCATION NARRATIVE – TRACE CREEK RD.

Repair and Repave approximately 800 LF x 22 Ft. of Trace Creek Rd.

Beginning at the intersection of Hwy 70 and Trace Creek Rd. in White Bluff, TN, the repair site runs approximately 800 LF northeastward on Trace Creek Rd. Repair area is indicated with “BEGIN” and “END” painted on the roadway surface. An approximate map of the area is shown above.
